**Subject: PROCEEDINGS OF THE CAMPUS UNFAIR MEANS CONTROL COMMITTEE, TERMINAL EXAMINATIONS, SP'23 SEMESTER**

The meeting of the Campus Unfair-Means Control Committee (CUMCC) was held on July 04, 2023 (in the Office of the Convener) to discuss unfair means cases, reported during the Terminal Examinations of the SP-2023 Semester. The Committee probed the reported unfair means cases in detail and made the following decisions in the light of the available facts, written statements/hearing of the students, written statements of the Invigilators/Examination Committee and the material on the record (under the Regulation No. 5(c), 5(e), 5(f), 6(d), 8(a) & 8(c), Revised Regulations relating to the use of Unfair-Means and Academic Dishonesty in Examinations, 2012):-

2. The Committee further decided that the information about the decision of unfair means cases will be displayed on all notice boards of the Campus. Furthermore, a letter of concern will be issued to the concerned student by the Registration Branch. The feedback regarding sending the letters will be forwarded to the Convener CUMCC.

3. It was agreed by the Committee Members that the Departmental Coordination Officer (DCO) of the concerned department will intimate the student about the decision.

4. It was further agreed that the mobile phones of the accused students will be returned after the submission of the prescribed affidavit on the stamp paper.

5. The student can file an appeal against the decision of the Committee with the **Appellant Committee** within ten working days only from the issuance of this notification. After the expiration of this time, no plea will be entertained.

6. The Committee members recommended to provide counseling to the indulged students in the Accessibility Center for the prevention of the drastic action in future. HoDs concerned will ensure their presence in the Accessibility Center.




